Subject: SEZ Biotech Services Private Limited-Hadapsar SEZ Levy of Fuel Adjustment Charges (FAC) for the Month of July 2025

Greetings!!

This circular is issued to inform all concerned consumers regarding the levy of Fuel Adjustment Charges (FAC) applicable for the billing month of **July 2025**.

SEZ Biotech Services Private Limited-Hadapsar SEZ is levying the FAC strictly in accordance with the Multi Year Tariff (MYT) Order issued by the Hon'ble Maharashtra Electricity Regulatory Commission (MERC) dated **28th March 2025**. As per the provisions of **Clause 10.2 of the MYT Regulations, 2024**, the distribution licensee is required to recover the variation in power purchase cost on a monthly basis. For example, the variation in power purchase cost for the month of **June 2025** is recoverable through the electricity bill issued for the month of **July 2025**.

Further, SEZ Biotech Services Private Limited-Hadapsar SEZ has recently received directives from the Hon'ble Commission regarding the immediate recovery of FAC, wherein the variation in power purchase cost for a particular month must be recovered in the subsequent billing month. Accordingly, the variation in power purchase cost for **June 2025** will be recovered through the **July 2025** electricity bill.

It is also to be noted that the post-facto approval from the Hon'ble MERC for the FAC amounts pertaining to the months of **April 2025 to June 2025** is under Process. Upon receipt of such approval, the applicable FAC will be adjusted and recovered in the forthcoming billing cycles, as per the guidelines laid down by the Commission.

The **category-wise FAC** applicable for recovery in the month of **July 2025** has been provided in **Annexure 'A'** attached herewith for reference.
